Independent Accountant's Report

We have reviewed the accompanying schedule of total scope 1, scope 2 and corporate business travel scope 3 greenhouse gas emissions for the year ended December 31, 2012 that AT&T Inc. calculated for its 2012 Sustainability Report. AT&T Inc.'s management is responsible for the schedule of total scope 1, scope 2 and corporate business travel scope 3 greenhouse gas emissions.

Our review was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. A review is substantially less in scope than an examination, the objective of which is the expression of an opinion on AT&T Inc.'s schedule of total scope 1, scope 2 and corporate business travel scope 3 greenhouse gas emissions. Accordingly, we do not express such an opinion.

Environmental and energy use data are subject to inherent limitations, given the nature and the methods used for determining such data. The selection of different but acceptable measurement techniques can result in materially different measurements. The precision of different measurement techniques may also vary.

Based on our review, nothing came to our attention that caused us to believe that the schedule of total scope 1, scope 2 and corporate business travel scope 3 greenhouse gas emissions of AT&T Inc. for the year ended December 31, 2012 is not presented, in all material respects, in conformity with the criteria described in footnote 1¹.

The above amounts represent the Scope 1, Scope 2 and corporate business travel scope 3 greenhouse gas emissions (in metric tonnes CO₂e) of AT&T Inc. (the Company) for the year ended December 31, 2012 included within the Company's 2012 Sustainability Report.

These amounts have been prepared based on the criteria provided by the Greenhouse Gas Protocol, A Corporate Accounting and Reporting Standard Revised Edition, published by the World Resources Institute (WRI) and the World Business Council for Sustainable Development (WBCSD). For calculations specific to US based activities guidance outlined by the US Environmental Protection Agency was also applied. The use of different criteria may result in different measurements.

AT&T has taken an operational control approach to define the Company's greenhouse gas inventory. Where available, greenhouse gas emissions are calculated on the basis of actual (i.e. metered) data; in certain instances where actual data is not available AT&T has estimated actual greenhouse gas emissions based on methodologies defined in the criteria listed above. For the year ended 2012, sufficient data or information to develop an estimation of the Scope 1 greenhouse gas emissions produced from refrigerant usage within its mobility operations was not available and was not estimated.
