Amerit Consulting really began in 1965 when Gary received his draft notice.

He joined the Navy that same year and soon enlisted in Corps School. As a Corpsman, Gary served on the ground in Viet Nam, and while helping fellow Marines during a series of land mine blasts, was hit in both legs and spent the next year recuperating in Naval hospitals. His heroic acts earned him a purple heart, and modern medicine allowed him to keep both legs.

Gary took his experience and turned it into support and outreach for other veterans through the development of a Disabled Veteran Owned Business, Amerit Consulting.

Amerit entered into the staffing and consulting industry in response to its perception that there was demand for diversity staffing companies, capable and willing to expand sufficiently to meet the needs of Fortune 500 companies. When researching diversity staffing companies, Amerit found a highly fragmented group of diversity suppliers typically with limited geographic and functional scope. The strategic focus, therefore, was partnerships, combining best practices... business development.

Amerit believes it is important to support other Small and Service-Disabled Veteran Owned businesses. As President and 52% owner, Gary, has a long history of working with the Service-Disabled Veteran Business community. For three years, from 2004 to 2007, Gary served as the President of the Central Valley DVBE Network in Sacramento. Currently, Gary is the Co-Chair of the California Department of Veteran Affairs (CDVA) Board and works closely

with Governor appointed Co-Chairperson Ted Puntillo in working with the disabled veteran community. He is also the First Vice President of the California DVBE Alliance, and Amerit is a member of the DVBE Alliance Corporate Advisory Board.

Gary's DVBE roles are for outreach designed to encourage entrepreneurial-minded disabled veterans and assist them in building business with the State. Gary looks for opportunities to interact and build relationships with other Small and DVBE staffing firms.

Today, Amerit is a Disabled Veteran Business Enterprise (DVBE) certified by the State of California, Department of General Services. Amerit is also a Federal SDVOSB (Service Disabled Veteran Owned Small Business) qualifying as a Small Business under NAICS code 561320, Temporary Employment Services.
