

AT&T “BALL FOR ALL” SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. AN INTERNET CONNECTION AND VALID EMAIL ADDRESS ARE REQUIRED TO ENTER. These “**Official Rules**” of the AT&T “Ball for All” Sweepstakes (“**Sweepstakes**”) shall serve to govern the Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to legal residents of the Continental United States and the District of Columbia (collectively the “**Eligibility Area**”), who as of the date of their entry and prize award are eighteen (18) years of age or older, have internet access and a valid email address account and do not have an NBA ID account with an existing subscription to NBA League Pass.

The Sweepstakes is void in Alaska, Hawaii, Puerto Rico, all other U.S. territories and possessions and overseas military installations and where prohibited. Employees and their immediate family members (spouses, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren) of Sponsor (defined below), NBA Properties, Inc., the National Basketball Association (the “**NBA**”), and the NBA member teams (collectively, the “**NBA Entities**”), Wasserman Media Group, LLC (“**Wasserman**” or “**Administrator**”), West Coast Marketing, a division of The Susquehanna Hat Company (“**West Coast Marketing**”) and each of their respective officers, directors, affiliates, subsidiaries, parent companies, and advertising and promotion agencies (collectively, the “**Sweepstakes Entities**”) and those living in the household of same (whether legally related or not) are not eligible to enter or win. SWEEPSTAKES WINNER SELECTION, NOTIFICATION & PRIZES: On/about 01/10/26 starting at 12:01AM CST, Ten Thousand (10,000) potential prize winners will be selected in a random drawing from among all eligible Entries received for the Sweepstakes. Random drawing will be conducted by representatives of the Sponsor or its designee.

Decisions of Sponsor, Wasserman and West Coast Marketing shall be final and binding in all matters relating to Sweepstakes.

Potential Sweepstakes winners (each a **“Potential Winner”** and collectively, **“Potential Winners”**) will be notified by 11:59PM CST on 1/21/26 with the delivery of their Prize (defined below).

Sweepstakes Prizes: Ten Thousand (10,000) prizes (each a **“Prize”** and collectively, **“Prizes”**) will be available to be awarded in the Sweepstakes. Each Sweepstakes Prize consists of a promo code* (**“Code”**) good for redemption of a partial 2025-2026 NBA League Pass streaming subscription, that will continue until the end of the 2025-2026 NBA season. An NBA ID (free at NBA.com) is required to redeem Code. In order to obtain an NBA ID you will be required to go to NBA.com/account/sign-in or use the NBA App, click “Create NBA ID” or “Sign In”, and enter your email and a password (8+ characters, 1+ capital, 1+ symbol/number.

Additional redemption conditions continue below. Once you have an NBA ID, log on to NBA.com and follow the directions to redeem your Code.

AWARDED OR RECOVERABLE; (3) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT-OF-POCKET EXPENSES NOT TO EXCEED FIFTY DOLLARS (\$50.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (4) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

FORCE MAJEURE: Releasees shall not be liable to a Prize Winner or any other person for failure to supply a Prize or any part thereof, by reason of any acts of God, any action(s), regulation(s), order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist acts, earthquake, war, pandemic, fire, flood, explosion, unusually severe weather, hurricane, embargo, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation interruption of any kind, work slow-down, civil disturbance, insurrection, riot, network or computer problems, internet problems, hacking, computer viruses, unauthorized computer access, tampering, or any other cause beyond Sponsor's sole control.

GENERAL: If for any reason this Sweepstakes or any part is not capable of running as planned, or if this Sweepstakes or any web site (including but not limited to the Sweepstakes Site associated therewith (or any portion(s) thereof) becomes corrupted or does not allow the proper participation in the Sweepstakes and processing of Entries in accordance with these Official Rules, or if infection by computer virus, bugs, tampering, unauthorized intervention, actions by Entrants, fraud, technical failures, or any other causes, in the Sponsor's sole opinion, corrupts or affects the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, the Sponsor reserves the right, at its sole discretion, to disqualify any individual implicated in such action and/or to cancel, terminate, modify, or suspend this Sweepstakes or any portion thereof.

In the event Sweepstakes or part thereof is cancelled, the Sponsor may in its sole discretion, conduct a random drawing to award the applicable Sweepstakes Prize(s) from among all applicable eligible, non-suspect Entries received for the Sweepstakes prior to the time of the action or event warranting such cancellation. If any such cancellation, termination, modification, or suspension occurs, notification will be posted at the Sweepstakes Site. The Releasees are not responsible for the actions of Entrants in connection with the Sweepstakes or part thereof, including Entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes or any part thereof. If a dispute arises about who submitted an Entry, the Entry will be deemed submitted by the authorized account holder of the email address account used. The authorized account holder of the email address account is deemed the natural person who actually is the named registered email address account holder. A potential Prize Winner may be requested to provide the Sponsor with proof that he/she is the authorized, named and registered account holder of the email address account associated with the winning Entry and that all eligibility requirements are met.

In the event a dispute regarding the identity of the individual who actually submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible.
