Offer overview

For full credit (maximum bill credit) to be issued:

- You must buy a qualifying smartphone on an installment agreement (new line or upgrade) and purchase a smartphone (add a new line) with qualifying wireless service (min. \$70/mo for new customers (min. 1st line \$50; 2nd line \$20).
- You must maintain eligible TV service and in good standing for up to 30 months (or for the duration of the offer and credits) to receive all offer credits.
- Your wireless billing address must match your TV service or billing address. Learn how to update your billing address.

Heads up: If your TV service is canceled, you must reactivate [DIRECTV](#) or [U-verse TV](#) service within 30 days to keep getting the credits. If it isn't reactivated within 30 days, offer credits will stop.

To qualify for wireless:

Offer restrictions
