

# Free iPhone 6s with new TV service offer (2017)

## *Offer details*

### **For wireless:**

- Eligible iPhone must be purchased online on an AT&T Next® installment agreement.
- The monthly bill credit will be applied in equal amounts towards installment charges over the agreement term (Credits are \$18.34 per month for 30 months or \$22.92 for 24 months).
- One free device per mobility account (within a 12-month period).
- Puerto Rico and Virgin Islands not eligible.
- Tax on full price due at sale.
- Wireless and DIRECTV or U-verse billing addresses or service addresses must match. [Learn how to update your billing address](#).

### **For DIRECTV:**

- New and existing DIRECTV accounts qualify.
- New customers activating new DIRECTV service require 24-month agreement. Minimum package of \$29.99 per month required.
- Excludes DIRECTV NOW.
- New service must be installed within 30-days of wireless plan activation.

### **For U-verse TV:**

- New and existing U-verse TV accounts qualify. There is no term commitment for new customers activating new U-verse TV service. Minimum package of \$19.99 per month required.
- New service must be installed within 30-days of wireless plan activation.

### ***Not meeting eligibility or canceling TV service***

- If qualifying wireless line is disconnected or cancelled prior to completing the installment agreement (24 or 30 months) or qualifying TV service is cancelled, you're responsible for remaining amount owed on the device installment agreement up to \$749.99 for eligible iPhone.
- If you upgrade, pay up, or pay off the line device agreement early, your credits may cease.

## *Bill credits*

Monthly bill credits will start within 3 bill periods. BOTH services must (1) remain active, (2) account in good standing, and (3) device must remain on its agreement for entire installment term (30 or 24 months) to get all its credits.

- If you cancel wireless service, you will owe remaining installment balance.
- If you upgrade, pay up, or pay off the agreement early, your credits may cease.
