

Get 50% off select smartphones (2018)

Learn how to get 50% off eligible smartphones when you sign up for TV or internet service or a new line.

Offer summary

You can get 50% off eligible smartphones when you either:

- Sign up for new DIRECTV®, U-verse® TV, or AT&T Internet service and upgrade or add a new line.
- Add a new line and already have DIRECTV, U-verse TV, or AT&T Internet.
- Phone must be purchased on installment agreement.

Offer details

For full credit (maximum bill credit) to be issued, you need to get a new phone line or upgrade your existing phone line and sign up for new DIRECTV, U-verse TV, or AT&T Internet service. (DIRECTV NOWSM isn't eligible.) Limit only one upgrade phone line at 50% off.

DIRECTV and U-verse TV requirements

- New or current wireless customers adding a new wireless line don't have any TV service requirements.
- New TV service (DIRECTV or U-verse TV) is required if you're a current wireless customer and you're upgrading your line to an eligible smartphone. Maximum one upgrade at 50% off.
- There isn't a minimum package requirement.

- Spanish packages are included.
- You need to install residential DIRECTV or U-verse TV service. If you're a new TV customer, you need to meet TV service eligibility requirements within 30 days of your wireless purchase.
- DIRECTV NOW isn't eligible.
- Multiple Dwelling Unit account customers are eligible (individual and bulk billed accounts).
- If you already have DIRECTV or U-verse TV, you'll need to add a new wireless line.
- Your service needs to be active and in good standing to receive monthly bill credits. You also need to keep your TV service for the life of the wireless installment term, which is 24, 30, or 36 months (the 36-month Equipment Installment Plan is only available for CRU customers).
- The address for your TV and wireless account bills needs to match.

AT&T Internet requirements

- If you're adding a new wireless line, you need to have existing eligible AT&T Internet service or add new AT&T Internet service.
- New AT&T Internet service is required if you're a wireless customer and are upgrading your line to an eligible smartphone. Maximum one upgrade at 50% off.
 - If you already have AT&T Internet, you'll need to add a new wireless line. There isn't a minimum speed requirement. All speeds and packages qualify.
 - If you're a corporate responsibility user (CRU) adding a new wireless line, you don't need to have eligible AT&T Internet service.
 - If you're a CRU upgrading an existing line, you need to add a new eligible AT&T Internet service.
- You need to install residential AT&T Internet service. If you're a new Internet customer, you need to meet Internet service eligibility requirements within 30 days of your wireless purchase.
- Multiple Dwelling Unit account customers are eligible (individual and bulk billing accounts).

- Your service needs to be active and in good standing to receive the monthly bill credits. You also need to keep your AT&T Internet service for the life of the wireless installment term (24, 30, or 36 months of an equipment installment plan (EIP) for CRU only).
- The billing addresses for your AT&T Internet and wireless accounts need to match.

Wireless requirements

- Adding a new line is eligible and you can qualify for multiple 50% off smartphone deals when you're adding new lines.
- Upgrading a line is only eligible with new TV or Internet service. You can only qualify for one 50% off smartphone upgrade per wireless account when you match it with a new TV or Internet service account. So, if you're upgrading multiple lines on your account, you'll get 50% off the lowest-priced device.
- Phones must be purchased on an installment agreement, which includes AT&T Next® (30-month financing option with either \$0 down or a down payment) or AT&T Next Every Year® (24-month financing with either \$0 down or down payment).

Monthly bill credits

If all requirements are met, monthly bill credits for the installment payment will start within three bill periods.

Specific restrictions
