- To qualify, your wireless billing address must be in an eligible ZIP Code in Charlotte or Raleigh, NC and you must bring your own device or buy a new smartphone from us outright.
- The following aren't eligible:
 - Upgrades
 - Data-only plans

- Installment agreements
- Tablets, watches, or basic or feature smartphones
- New line activations without a transfer
- AT&T PREPAIDSM or Cricket account conversions
- Current AT&T wireless accounts (or if you return to AT&T within 59 days of cancellation)

Bill credits

If you meet all the offer requirements, your bill credits start on the date you activate your account. We'll credit your account for all eligible charges within 15 to 20 days.

Heads up: You'll get a bill with all first-month charges applied. Also, you'll get a follow-up text when we apply the credits. You don't need to do anything.

Charges we'll credit:
